2	<b>Clause No. 6.0 Security Deposit (SD)</b> (a) For due fulfillment of the contractual obligations, the successful bidder shall furnish Security Deposit in the form of Bank Guarantee / Demand Draft / Pay Order for a sum equal to 3% of the contract value within 15 days from the date of issue / receipt of the Purchase Order. The Security Deposit shall remain valid till Warranty / Guarantee period. In case security deposit is not submitted within 15 days from the date of issue of P.O, the release of security deposit will be after taking into account of the corresponding period of delay in submission of the same even though the warranty / guarantee period expires. (b) Security Deposit may also be built up by deducting the amount proportionately from each bill of the contractor on their request. However, 50% of the total amount of the Security Deposit is to be deposited by the successful bidder on receipt of Purchase Order. Balance 50% may be recovered from running bill. This option of security deposit submission if availed, there shall be no change afterwards. (c) Security Deposit may be waived for SSI, NSIC, MSME units, DGS & D registered bidders, Registered Co-operative Society and PSUs. (d) Security Deposit will be returned only on completion of contractor's obligations under the contract including any warranty obligation or specified in the contract.	<b>6.0 Indemnity Against Damage or Loss of Goods in Transit:-</b> <b>6.1</b> An amount of Rs. 5,00,000/- to be deposited in the form of DD or BG in favour of "SAIL RITES BENGAL WAGON INDUSTRY PRIVATE LIMITED, Kulti" to safe guard the material from any transit damage or loss. <b>6.2</b> In case of any transit loss or theft of material the equivalent amount calculated on the basis of last SS material price will be realized from the deposited amount.  The DD/BG shall be retained by the company for a period extending three months beyond the validity period of the contract. In case of the contract is extended for further period, the validity period of the DD/BG shall also be extended accordingly. The DD/BG shall be returned after completion of the validity of the contract period as above and submission of "NO DUES CERTIFICATE" by the contractor obtained from the executing Authority and the operating Authority and compliance of statutory provision after deduction of any duties from the contractor arising out of any claim by SRBWIPL, kulti on the contractor.
